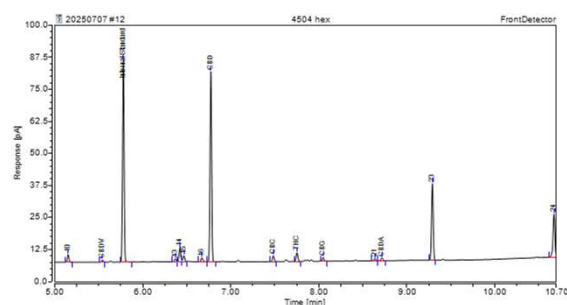

CHROMATOGRAM OF CANNABINOID PROFILE

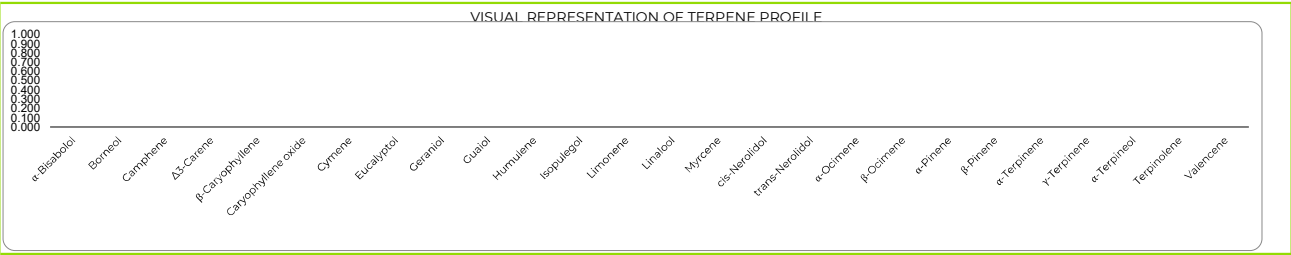
